IRVINE, California – Optimus EMR, Inc. announced today, that effective January 22, 2015 the Ohio Board of Pharmacy certified its bi-directional pharmacy interface connected to both Omnicare Software systems using NCPDP 10.6 messages.

The certification verbiage from the Ohio Board of Pharmacy is:

Optimus EMR is approvable in Ohio as demonstrated on January 22, 2015 with Omnicare's OmniDX and OASIS pharmacy systems. Optimus uses a username and password plus proximity card to log in, with 60-second time out invoked correctly for approvable positive ID. The fields for Sig and Notes transmissions alert the user and pharmacy to exceeding field lengths per new NCPDP 10.6 requirements. This is a bidirectional transfer between the nursing home and pharmacy. Therapeutic interchange is handled correctly in this system. Optimus, OmniDX and OASIS were previously reviewed and made approvable; this is a current update for each with NCPDP 10.6 and bidirectional transmissions.
